CHAIRMAN'S MESSAGE

In all my long years associated with the Koperasi, either as Chairman or Director, I have the courage and conviction to say that we are very transparent in administering our Koperasi. All decisions and policies arising are made collectively by the Board of Directors and then brought forward at the AGMs for members knowledge.

Our financial accounts are audited by the Internal and External Auditors yearly. Furthermore, the Suruhanjaya Koperasi Malaysia (SKM) acting as a "Watch Dog", strictly supervises the activities and administration of the Koperasi into complying with the various Co-operative Acts. Hence, I can assure all members that our Koperasi is "well and sound" and there is no room for any "hanky-panky".

To illustrate that our Koperasi is robust and strong, I wish to bring you back to 1991, when we hit the RM one million mark in net profit. That's a long 22 years. And since then, to our last audited accounts in 2012, we have never missed hitting the one million (RM) target in our net profits (except in 2002 where a RM967,207.00 net profit was made). At the time this message is being delivered, I am pleased to inform you that from our unaudited accounts for the financial year ending 31.12.2012, we have made a profit of RM 2.1 million and I can assure you that we can declare a higher dividend.

To consolidate further, our Koperasi in 2009 was awarded a 4-Star ranking out of a maximum of 5 by the SKM after an intensive "Due Diligence" Examination. Also in that same year, our Koperasi emerged proudly with a ranking of 29 among the best 100 co-operatives in the country. The icing in the cake came in 2011 when we were awarded the "Anugerah Inovasi Dan Kreative" together with a monetary reward of RM10,000.00

Our Koperasi has also applied to the SKM for payments of Bonus Shares to all members. The SKM has replied that it would consider it after the accounts for the financial year (2012) has been audited and a Bonus Share Redemption Fund has been created. We have duly instructed our External Auditor to do the necessary for that purpose.

Thus far, serving as either Chairman or Director, has both been challenging and satisfying. I hope that the in-coming and future members of the Board of Directors have the dedication and passion to bring the Koperasi to greater heights.

Lastly, I take this opportunity to thank all past and present members of the Board, the staff and most importantly all the members for their unwavering support and contributions to the Koperasi.

DATE AND VENUE OF 81ST AGM

The 81st Annual General Meeting of the Cooperative will be held at Dewan Che Hoon Khor Moral Uplifting Society, 360 Jalan Macalister, Penang on Sunday 30 June 2013 at 9.30 a.m.

REGISTRATION OF MEMBERS ATTENDING THE AGM

Members attending the forthcoming Annual General Meeting are requested to take note of the following registration procedures.

Registration will commence at 8.00 a.m. and end at 10.30a.m. SHARP. However, the meeting will start at 9.30 a.m. Only members who have obtained the attendance memo before 10.30 a.m. will be eligible to vote, claim the meeting allowances and participate in the lucky draw.

During registration members must produce their membership cards and identity cards.

At the registration counters, members will be issued the following:

- i) ballot papers
- ii) lucky draw slips
 - iii) meeting allowance claim slips

The nine registration counters to be set up are

- **Counter No. 1**: Membership numbers beginning with letters A, B, D, E, F and G.
- **Counter No. 2**: Membership numbers beginning with letter C.
- Counter No. 3: Membership numbers beginning with letter H, I, J and K.
- Counter No. 4: Membership numbers from L0001-L0500
- Counter No. 5: Membership numbers from L0501 and above

- **Counter No. 6**: Membership numbers beginning with letters M, N and O.
- **Counter No. 7**: Membership numbers beginning with letters P, Q, R and S.
- **Counter No. 8**: Membership numbers beginning with letter T.
- **Counter No. 9**: Membership numbers beginning with letters U, V, W, Y and Z.

Members who are doubtful as to which counters they are required to register should consult the CONTROL COUNTER set up for this purpose.

New members whose membership were approved after 29 April 2013 are not eligible to attend the Annual General Meeting.

Members are asked to co-operate by not bringing their spouses who are non-members or their children to the Annual General Meeting. They will not be admitted into the meeting hall as non-members are strictly not allowed at the meeting.

ATTEND THE AGM AND WIN ATTRACTIVE PRIZES
